Affiliate Dues are payable at the time of application. A portion of the dues are sent to the Illinois Association of REALTORS® and entitles you to Affiliate Membership in that organization. If you already hold Primary Affiliate Membership in another Association then you will only be charged for Local Association dues. Please note the Association in which you hold Primary Affiliate Membership

Article IV, Section 1 (c): Affiliate Members shall be real estate owners and other individuals or firms who, while not engaged in the real estate profession as defined in paragraph (a) or (b) of this Section, have interests requiring information concerning real estate, and are in sympathy with the objectives of the Association (See reverse for objectives of the Association).

Article II – The objectives of the Association are:

- Section 1. To unite those engaged in the recognized branches of the real estate profession in this community for the purpose of exerting a beneficial influence upon the profession and related interest.
- Section 2. To promote and maintain high standards of conduct in the real estate profession as expressed in the Code of Ethics of the National Association of REALTORS®.
- Section 3. To provide a unified medium for real estate owners and those engaged in the real estate profession whereby their interests may be safeguarded and advanced.
- Section 4. To further the interest of home and other real property ownership.
- Section 5. To unite those engaged in the real estate profession in this community with the Illinois Association of REALTORS® and the National Association of REALTORS®, thereby furthering their own objectives throughout the State and Nation, and obtaining the benefits and privileges of membership therein.
- Section 6. To designate, for the benefit of the public, those individuals within its jurisdiction authorized to use the terms REALTOR® and REALTORS® as licensed prescribed and controlled by the National Association of REALTORS®.
- Section 7. To encourage political involvement of individual members and of the Association.

Article IV, Section 1 (a): REALTOR® Members – Individuals who, as sole proprietors, partners, corporate officers, or branch office managers, are engaged actively in the real estate profession, including buying, selling, exchanging, renting or leasing, managing, appraising for others for compensation, counseling, or financing, building, developing or subdividing real estate, and who maintain or are associated with an established real estate office in the State of Illinois. All persons who are partners in a partnership, or all officers in a corporation, who are actively engaged in the real estate profession within the state shall qualify for REALTOR® Membership only, and each is required to hold REALTOR® Membership in an Association of REALTORS® within the State unless otherwise qualified for Institute Affiliate Membership as described in Section 1 (b) of Article IV.
